Silence! The Court Is in Session (1967), a play which is originally written in Marathi (Shantata! Court Chalu Ahe) and later translated into English by Priya Adarkar and staged in 1971 at Museum Theatre, Madras in march 1971. In Silence! The court is in session, Tendulkar has depicted the plight of Leela Benare who is schemed by the male dominated society. A Traditional society has never been able to come out of its values and customs. Our culture is a male dominant one. The Indian women exist among conditions often bordering on dismay. What Tendulkar depicts in his play is woman, they fight for their own life and their right to their own lives. This represents the patriarchal treatment and injustice on women. Victimisation of innocent women is one of the continuous concepts.
