A critical study of Incest in D.H. Lawrence's Sons and Lovers.

"Lord, let my father die." [S.L; P:59]

In one occasion when his father was hospitalized, we can see Paul taking the identity of his father andjoyfully plays the role of husband.

"Iam the man in the home now". [S.L; P:86]

Paul always loved to sleep with his mother and yearned for her physical warmth. This is a psychology of incestuous tendency in him. The scene in which Paul and Mrs. Morel go to Lincolnshire has clear sexual overtones. When Mrs. Morel complain of his extravagance, Paul immediately retorts:

"You forget Iam a fellow taking his girl for an outing". [S.L; P: 143]

Besides these facts, we can see Paul engage in love relations with other women like Clara and Miriam. But he can't fully stay live in these relations as he was much enclosed in the cocoon of his mother's protectiveness. He ultimately finds fulfilment in the emotional and physical warmth of motherhood.

We are left with no doubt that Mrs. Morel is the power behind Paul. Two examples can be taken to probe a little deeper into Paul's psychic functioning. Paul often strokes his mother's face with affection, buries his mouth deep into her throat and kisses her fervently. But at the same time, in case of Miriam, when she tries to come near, he is instinctively repelled.

Woman's sexual desires are strongest and the most keenly wishes to have them satisfied. Gertrude Morel even didn't get a chance to have her sexual desires fulfilled, a mental, physical satisfaction fromher husband. For its fulfilment, she approaches her male child Paul Morel.

Conclusion

Paul and his mother received no love from inside or outside their family. So they built their own Worldand lived happily. Paul trapped by the conflict between his ego and super ego and inertly and subconsciously, he begins to feel a soft corner for his mother. It eventually turns to an incestuous lovewhich is natural for a son like Paul. The circumstances were favourable for him. So either Paul or Mrs. Morel can't be blamed for their incestuous love. Paul finds no solace either from his family or his girl friends after his mother's death. He prefers lonely wandering and is not accusing anyone. He doesn't feel contempt for his incestuous love. Both Paul and his mother are positive thinkers till the end.
