By practicing the four pillars of this spiritual knowledge i.e. Knowledge, Meditation, Service, and by becoming the embodiment of knowledge, one can achieve a state of spiritual enlightenment. It's important to note that these beliefs are specific to the Brahma Kumaris and may differ from traditional angelology in other religious systems.

The Biological Perspective of Human Light Emission High-intensity bioluminescence, like that seen in fireflies, has led to the recognition that almost all living cells and organisms release an extremely faint luminescence. The intensity has been estimated at about one Photon per cell in 3 to 20 minutes for mammalian cells. It tends to be strongest in the red end of spectrum and weakest in the blue (Edward et al.1990). Photons are light particles that are generated within the body, these could be measured as they emanate from the skin. Chemical reactions within the body besides liberating energy and producing heat are also emitting small number of photons. The light emitted by the human body is 1000 times less intense than the levels to which our naked eyes are sensitive.

Dr. Popp was of the opinion that light is there in nature, and it is used by plants during photosynthesis. When we eat plant food, it must be that we take up the photons and store them.

This energy is the driving force for all the molecules in our body. Before any chemical reaction can occur, at least one electron must be activated by a photon with a certain wavelength and enough energy. Photons switch on the body's processes like an orchestra conductor bringing each instrument into the collective sound.

According to Veljkovic and Cosic, there are about 100,000 chemical reactions happening in every cell each second. The chemical reaction can only happen if the molecule which is reacting is excited by a Photon. After energizing the reaction, the photon reverts to its field, ready for subsequent reactions. We are swimming in an ocean of light.

But it is important to contemplate that despite the availability of light in the DNA the aura of light collapses as soon as the soul leaves the body. Biophotons and Disease

Dr. Popp studied healthy individuals and found an exquisite coherence at the quantum level, but also found an incoherent pattern among cancer patients. He tried out his machine on a series of Cancer patients. In every instance, the patients had lost natural periodic rhythms as well as coherence. The lines of internal communication were scrambled. They had lost their connection with the world. In effect, their light was going out.

Photorepair: DNA's Role in Restoration

From the biological laboratory experiments, it is clear that if you blast the cell with UV light so that 99% of the cell including its DNA is destroyed, you can almost entirely repair the damage in a single day just by illuminating the cell with the same wavelength at much weaker intensity. This is called photo repair. Dr. Popp found that patients with xeroderma pigmentosum eventually die because of skin cancer because the photo repair system cannot repair solar damage. This means that the must be some kind of light in the body responsible for photo repair. A Compound must cause cancer because it permanently blocks this light and scrambles it, so Photorepair cannot work anymore.

After intensive research, Popp found that the source of light and Biophoton emission is the DNA. DNA was like the master tuning fork of the body. It would strike a particular frequency and certain molecules would follow. Biophotons have a much larger role to play, when it comes to our physiology and quite possibly our consciousness as well. The light emitted from each individual being forms the aura and is directly related to the body's Chakra systems (interaliamag.org)

In biological experiments, it's evident that exposing a cell to UV light to the extent that 99% of it, including its DNA, is damaged can be almost completely restored within a day by subjecting the cell to the same light wavelength but at a significantly reduced intensity. This process is "photo repair" as discussed above. Dr. Popp discovered that individuals with xeroderma pigmentosum typically succumb to skin cancer since their photorepair mechanism fails to mend the damage caused by sunlight. This suggests the presence of a specific light within our body that facilitates photo repair. Any compound that causes cancer likely does so by permanently obstructing this light, rendering photorepair ineffective.

Upon extensive study, Dr. Popp concluded that DNA is the primary source of biophoton emissions. It functions much like a body's central resonator, emitting specific frequencies that resonate with certain molecules. Biophotons have a profound influence not only on our physiological processes but potentially on our consciousness as well. The emitted light from each individual shapes the aura, which is intrinsically connected to the body's Chakra systems. Layton (2009) also talked about a new world of light, where he experienced himself to be an entity of light along with many more and they had an idea to create a new world.

"As we began to contemplate and think what it was, we wanted, creation spontaneously occurred before us. All we had to do was think and it was so. As one thing was created, we contemplated it and expanded our thought, with an expanded idea and as we did, that expanded idea came into form. Everything was formed in this manner."

Biological research supports Brahmakumari's depiction of Angels, emphasizing our nature as light beings. When in good health and maintaining a positive mindset, the photons we emit exhibit greater coherence than when we are unwell, reflecting a misalignment in our energy.
